MEDICAL EXPENSES INCURRED UP TO 12 MONTHS FROM THE DATE OF INJURY ARE COVERED

ALL SUBSEQUENT OUTSTANDING CLAIMS DOCUMENTATION MUST BE SUBMITTED WITHIN 15 MONTHS FROM THE DATE OF INJURY

ALL PHYSIO CLAIMS MUST BE REFERED BY A QUALIFIED MEDICAL PRACTITIONER FIRST

A COPY OF THE REFEREE REPORT MUST BE RETURNED WITH ALL CLAIM FORMS. IF THE INJURY DID NOT OCCUR DURING A MATCH, A LETTER FROM THE CLUB SECRETARY MUST BE PROVIDED CONFIRMING THE PLAYER WAS INJURED AS PART OF AN OFFICAL CLUB TRAINING SESSION / ACTIVITY
